Third I give and bequeath to my Sister Elizabeth M White three negroes viz Lydia and her two children Rose and October, which I will to her and her if sue Fourth, I give and bequeath to my brother John M White one young fellow named Six. Fifth I give and bequeath to my sister Mary Daniels one negro woman named Willoughby, which I will to her and her ifsue. Sixth I give and bequeath to my brother Joshua M White my tract of Land situated in the above said State & parish on Murray's Ferry road. Seventh. I wish all my remaining negroes which are six in number viz Monday, Mingoe Betty, Lisette, Patty and Cain with all the rest of my personal property to be sold and all just demands to be paid which are against my estate. It is also my wish that what money is left from paying my debts shall be put on interest which Interest alone to be given to my father Joshua M White for a support during his life.
